Unit 1: History of the Earth

OVERVIEW

Summary

Students will be introduced to the concepts of plate tectonics and the geologic layers of the earth. They will look at evidence, including age, mineral content and physical properties of rocks to determine the relative age of continental and oceanic rock. They will use radiometric data to determine the approximate age of rocks. They will use models to show how convection currents influence the movement of crustal rock. Students will explore the interconnectivity of mantle convection currents and plate tectonics.

Content to Be Learned

- Continental rocks, which can be older than 4 billion years, are generally much older than the rocks of the ocean floor, which are less than 200 million years old.
- Plate tectonics is the unifying theory that explains the past and current movements of the rocks at the earth's surface and provides a framework for understanding its geologic history.
- Spontaneous radioactive decays follow a characteristic exponential decay law. Nuclear lifetimes allow radiometric data to be used to determine the ages of rocks and other materials.
- Earth's systems, being dynamic and interacting, cause feedback effects that increase or decrease the original changes.
- The foundation for earth's global climate systems is the electromagnetic radiation from the sun, as well as its reflection, absorption, storage, and redistribution among the atmosphere, ocean and land systems, and this energy's re-radiation into space.
- Evidence from deep probes and seismic waves, reconstructions of historical changes, and earth's surface and its magnetic field, and an understanding of physical and chemical processes lead to a model of earth with a hot but solid inner core, a liquid outer core and a solid mantle and crust. Motions of the mantle and its plates occur primarily through thermal convection, which involves the cycling of matter due to the outward flow of energy from the earth's interior and gravitational movement of denser materials towards the interior.
- The radioactive decay of unstable isotopes continually generates new energy within earth's crust and mantle, providing the primary source of the heat that drives mantle convection. Plate tectonics can be viewed as the surface of mantle convection.
- Cyclical changes in the shape of the earth's orbit around the sun, together with changes in the tilt of the planet's axis of rotation, both occurring over hundreds of thousands of years have altered the intensity and distribution of sunlight falling on the earth. These phenomena cause a cycle of ice ages and other gradual climate changes.

- The geologic record shows changes to global and regional climate can be caused by interactions among changes in the sun's energy output or earth's orbit, tectonic events, ocean circulation, volcanic activity, glaciers, vegetation, and human activities. These changes can occur on a variety of time scales from sudden to intermediate to very long tectonic cycles.

Essential Questions

- How does the the movement of continental and oceanic crust, along with the theory of plate tectonics, explain the age of rocks?
- How and why is the earth constantly changing?
- How do the earth's surface processes and human activities affect each other?
- Why is thermal convection the driving force for the cycling of matter in the earth's interior?
- Using specific examples, how does water and its unique properties affect earth materials and surface processes?
- How can a model demonstrate the impact of how one geologic change can create and cause changes to other earth systems?

Unit 2: The Dynamic Earth

OVERVIEW

Summary

Students will explore the combination of factors that interplay to create earth's global systems. They will look at evidence from the geologic record to look for evidence of the earth's changing systems. They will be able to explain how global and regional climate changes are the result of interactions among changes to many phenomena including the sun's energy output, earth's orbit, tectonic events, ocean circulation, and human activities. They will explore the physical properties of water and how the molecule influence the dynamics of the planet. Finally, they create a model to describe the cycling of carbon between the atmosphere, biosphere, hydrosphere, and geosphere.

Content to Be Learned

- Cyclical changes in the shape of the earth's orbit around the sun, together with changes in the tilt of the planet's axis of rotation, both occurring over hundreds of thousands of years have altered the intensity and distribution of sunlight falling on the earth. These phenomena cause a cycle of ice ages and other gradual climate changes.
- The geologic record shows changes to global and regional climate can be caused by interactions among changes in the sun's energy output or earth's orbit, tectonic events, ocean circulation, volcanic activity, glaciers, vegetation, and human activities. These changes can occur on a variety of time scales from sudden to intermediate to very long tectonic cycles.
- The foundation for earth's global climate systems is the electromagnetic radiation from the sun, as well as its reflection, absorption, storage, and redistribution among the atmosphere, ocean and land systems, and this energy's re-radiation into space.
- The abundance of liquid water on earth's surface and its unique combination of physical and chemical properties are central to the planet's dynamics. These properties include water's exceptional capacity to absorb, store, and release large amounts of energy, transmit sunlight, expand upon freezing, dissolve and transport materials, and lower the viscosities and melting points of rocks.
- Gradual atmospheric changes were due to plants and other organisms that captured carbon dioxide and released oxygen.
- Changes in the atmosphere due to human activity have increased carbon dioxide concentrations and thus affect climate.
- The many dynamic and delicate feedbacks between the biosphere and other earth systems cause a continual co-evolution of earth's surface and the life that exists on it.

These properties include water's exceptional capacity to absorb, store, and release large amounts of energy, transmit sunlight, expand upon freezing, dissolve and transport materials, and lower the viscosities and melting points of rocks.

Unit 3: Earth's Climate

OVERVIEW

Summary

Students will then explore the combination of factors that interplay to create earth's global climate systems. They will look at evidence from the geologic record to look for changes in global and regional climate. They will be able to explain how global and regional climate changes are the result of interactions among changes to many phenomena including the sun's energy output, earth's orbit, tectonic events, ocean circulation, and human activities.

Content to Be Learned

- Earth's systems, being dynamic and interacting, cause feedback effects that increase or decrease the original changes.
- The foundation for earth's global climate systems is the electromagnetic radiation from the sun, as well as its reflection, absorption, storage, and redistribution among the atmosphere, ocean and land systems, and this energy's re-radiation into space.
- Cyclical changes in the shape of the earth's orbit around the sun, together with changes in the tilt of the planet's axis of rotation, both occurring over hundreds of thousands of years have altered the intensity and distribution of sunlight falling on the earth. These phenomena cause a cycle of ice ages and other gradual climate changes.

- The geologic record shows changes to global and regional climate can be caused by interactions among changes in the sun's energy output or earth's orbit, tectonic events, ocean circulation, volcanic activity, glaciers, vegetation, and human activities. These changes can occur on a variety of time scales from sudden to intermediate to very long tectonic cycles.
- The foundation for earth's global climate systems is the electromagnetic radiation from the sun, as well as its reflection, absorption, storage, and redistribution among the atmosphere, ocean and land systems, and this energy's re-radiation into space.
- Changes in the atmosphere due to human activity have increased carbon dioxide concentrations and thus affect climate.

Unit 4: Human Activity and the Earth

OVERVIEW

Summary

Students will explore and analyze the interactions between earth and humans and their activities. They will look at how geologic events have shaped the course of human history and influenced human activity. They will analyze various energy productions and resource extractions for their economic, social, environmental and geopolitical costs and benefits. They will explore new technologies as possibilities to balance these factors. They will create a simulation to illustrate the relationship between natural resource management, the sustainability of human populations, and biodiversity. They will look at technologies that could reduce the impact of human activities on natural systems. They will analyze data and look at current climate change models to make an evidence-based forecast of the rate of global and regional climate change and the associated impact on earth systems. Finally, they will explore the relationships between various earth systems and how those relationships are being influenced by human activities.

Content to Be Learned

- Resource availability has guided the development of human society.
- Natural hazards and other geologic events have shaped the course of human history, and have significantly altered the sizes of human populations and have driven human migrations.
- All forms of energy production and other resource extraction have associated economic, social, environmental, and geopolitical costs and risks as well as benefits. New technologies and social regulations can change the balance of these factors.
- The sustainability of human societies and the biodiversity that supports them requires responsible management of natural resources.
- Scientists and engineers can make major contributions by developing technologies that produce less pollution and waste and that preclude ecosystem degradation.
- Though the magnitudes of human impacts are greater than they have ever been, so too are human abilities to model, predict, and manage current and future impacts.
- Current models predict that, although future regional climate changes will be complex and varied, average global temperatures will continue to rise. The outcomes predicted by global climate models strongly depend on the amounts of human-generated greenhouse gases added to the atmosphere each year and by the ways in which these gases are absorbed by the ocean and biosphere.
- Through computer simulations and other studies, important discoveries are still being made about how the ocean, the atmosphere, and the biosphere interact and are modified in response to human activities.

Unit 5: Space Systems

OVERVIEW

Summary

Students will construct an explanation of the Big Bang Theory based on evidence from stars' light spectra, observations of distant galaxies and composition of matter in the universe. They will understand the function of nuclear fusion in creating atomic matter. They will explore how Newtonian gravitational laws and Kepler's laws govern orbital motions of planets, moons and satellites. They will use evidence from meteorites and other planetary surfaces to construct an account of earth's formation and early history. Finally, they will use radioactive decay to determine the age of rocks and other materials.

Content to Be Learned

- The study of stars' light spectra and brightness is used to identify compositional elements of stars, their movements and their distances from earth.

- The Big Bang Theory is supported by observations of distant galaxies receding from our own, of the measured composition of stars and non-stellar gases, and of the maps of spectra of the primordial radiation that still fills the universe.
- Other than the hydrogen and helium formed at the time of the Big Bang, nuclear fusion within stars produces all atomic nuclei lighter than and including iron, and the process releases electromagnetic energy. Heavier elements are produced when certain massive stars achieve a supernova stage and explode.
- Kepler's Law describes common features of the motions of orbiting objects, including their elliptical paths around the sun. Orbits may change due to the gravitational effects from or collisions with other objects in the solar system.
- Although active geologic processes, such as plate tectonics and erosion, have destroyed or altered most of the very early rock record on earth, other objects in the solar system, such as lunar rocks, asteroids, and meteorites, have been changed little over billions of years. Studying these objects can provide information about earth's formation and early history.
- Spontaneous radioactive decays follow a characteristic exponential decay law. Nuclear lifetimes allow radiometric data to be used to determine the ages of rocks and other materials.
